

HOA Meeting 3-21-08      Called to order at 7:04 pm

Homeowner's forum issues.

Can homeowners object to tennis lessons? They don't want to have to compete with tennis lessons.

A. They were directed to the website and Kathy Conrad, Chair of the Architectural Review Board.

Neil Geitner mentioned that no one from the board attended the Willows Water meeting in March. He said a representative from Denver Water was there explaining that if an association could save 25% in water a rebate would be given to that association. To get this you have to have a design implementation plan. We would need to spend a sizeable amount to get that rebate, perhaps \$250,000.00. We currently have 1 tap. Realistically we need another tap. Deb Pilon is the manager at Willows Water 770-8625 is her contact.

A resident who's neighbor had a Pod in front of their house wanted to know what can he do?

A. Many attempts have been made to contact the offending neighbor. So far there has been no answer. The first fine letter went out this week. Pods will be contacted and told that is an unauthorized Pod and they need to remove it. In addition there is a city ordinance as well.

**Insurance.** The property has been re-written to bring it to the actual amounts. We can get the check cut as all issues have been addressed.

**Pine Beetle Spraying.** It was recommended that we go ahead and do that. Ground Masters will do this for \$985 per application, there are 2 applications. That includes fertilization. Before we approve that cost we will look into the CSU extension service website and ask Kay Geitner for her South Suburban expertise and recommendation. What species of pines do they affect?

New Trees. We have \$3000.00 budgeted but it was agreed to hold-off doing any additions, given Arapahoe Parks is not doing their tree program this year.

Topic 5 New business

**Reserve Study Proposals.** We have 2 proposals – Aspen Reserve Specialists and Association Reserves. We are waiting on a 3<sup>rd</sup> proposal from Brad Lee. We will want a comprehensive plan. Jeff Mueller wants 3-4 references from each company for associations roughly our size or larger.

**Spring Walk Through.** It was agreed that each person would be assigned a section of the neighborhood. We won't do it as a group, but each person has a deadline of May 10<sup>th</sup>. Digital photos will be taken of each violation.
